SY 2023-24 NSLP Application is Open

- The SY 23-24 Renewal Application is now open and needs to be completed
- You must insert an FY 24 application first
- 525 of the 540 applications are approved
- You cannot file a claim until your FY 24 application is approved

CEP ISP Changes

- USDA issued some new CEP and the Minimum Identified Student Percentage (ISP)
- The ISP has been lowered from 40% to 25%
- The 1.6 multiplier has not changed and cannot unless Congress makes that change
- Oklahoma will be completing a State Waiver for this change more info to come on this and the start month

CEP ISP Changes

- CEP is based solely on Direct Certification numbers NOT free or reduced-price information
- Direct Certification Medicaid (DC-M) Free can be used but DC-M reduced can NOT be used for CEP
- This change does not go into effect until October 26, 2023, and we are waiting to get some additional State guidance from USDA

Changes to CEP as a Result of the Final Rule		
Provision (current regulatory citation)	Previous Minimum ISP	New Minimum ISP (effective 10/26/2023)
Minimum ISP (7 CFR 245.9(f)(3)(i))	LEAs, schools, and groups of schools were required to have ISPs of <u>40 percent or higher</u> to elect CEP.	LEAs, schools, and groups of schools are required to have ISPs of <u>25 percent or higher</u> to elect CEP.
Grace Year Eligibility (7 CFR 245.9(f)(4)(ix))	LEAs, schools, and groups of schools participating in CEP were required to have ISPs of <u>less than 40 percent but equal to or greater than 30 percent</u> in year 4 of the CEP cycle to elect CEP for a fifth year, or grace year. ($30 \leq \text{ISP} < 40$)	LEAs, schools, and groups of schools participating in CEP are required to have ISPs of <u>less than 25 percent but equal to or greater than 15 percent</u> in year 4 of the CEP cycle to elect CEP for a fifth year, or grace year. ($15 \leq \text{ISP} < 25$)
Identification, Notification, and Publication of <i>Eligible</i> LEAs and Schools (7 CFR 245.9(f)(5), (6), (7))	Eligible LEAs or schools had ISPs of <u>40 percent or higher.</u>	Eligible LEAs or schools have ISPs of <u>25 percent or higher.</u>
Identification, Notification and Publication of <i>Nearly Eligible</i> LEAs and Schools (7 CFR 245.9(f)(5), (6), (7))	Nearly eligible LEAs and schools had ISPs of <u>less than 40 percent but equal to or greater than 30 percent.</u> ($30 \leq \text{ISP} < 40$)	Nearly eligible LEAs and schools have ISPs of <u>less than 25 percent but equal to or greater than 15 percent.</u> ($15 \leq \text{ISP} < 25$)

Supply Chain Assistance Funds Round 4

- The 4th round of SCA funds have been issued if your district opted-in
- Use OCAS Project Code 759
- Can only be used on non-processed or minimally processed foods, think milk and fruits and vegetables
